Attached is a library card application for your child. Please assist them in completing the top sections. In order for your child to get a South Pasadena Public Library card:

- 1. You must sign the application next to "Signature Parent." The name of the parent who signs the library card application must match the name of the parent on the address verification information.
- 2. Provide a piece of valid photo identification, which verifies your child's current address. A piece of current mail or a current bill are all acceptable, as long as your child's name and/or your name and current address are given. The address on the identification form must match the address on the library card application. Parent's library cards are not acceptable as proof of address.
- 3. Have your child sign his/her first and last name on the application form.

Your child's class will be visiting the public library later this month. We would like for each child to be able to check out materials when they visit the library. To be able to check out materials, your child would need a library card. Please return to the library with your child, the completed application, and your identification prior to your child's library visit. We will prepare a library card for your child to take to the library on the day of his/her visit.

Thank you for your cooperation and assistance in helping us toward our goal of getting a library card for every eligible child. Please call me at (626) 403-7358, if you have any further questions.



You do not need to be a resident of South Pasadena to get a card.

Adult applicants must present photo identification and proof of mailing address with this application. Identification may be any of the following:

- Photo ID may include California driver's license or California ID, student or work photo ID, passport, or any government issued photo ID.
- Proof of mailing address, if not on your photo ID, may include an envelope/ postcard with a recent postmark, utility bill, rental agreement, personalized check, or car registration.

JUVENILE LIBRARY CARD APPLICATION

Please read carefully and print legibly.

Parents or legal guardians are responsible for all materials taken out on their child's/teen's library card. *Fees will be assessed for late, damaged or lost materials.*

A parent or legal guardian must be present to sign the library card application in order for it to be valid and present ID as listed above. Parents are responsible for **ALL** materials taken out on this card.
